<u>Pre-Meeting Business:</u> The Chairman stated that Mrs. White was present as a representative of the local press and was not a member of the Parish Council.

Public Participation: Ms. Ketteringham had received a letter from Pegasus Group, planning consultants working in partnership with Shared Access, regarding the proposed telecommunications mast. She agreed that the project would improve communications and provide additional funds for the Parish Council to utilise but wondered if any other sites had been considered. She said that she has had to put up with the tennis club lights for many years and wondered if larger shades could be used. Mr. Cameron also appreciated the benefits to the parish but felt that the mast would be visually detrimental to residents. In addition, it would be sited in a Conservation Area. He was surprised that the mast, if approved, would be 17.5 metres high as the original indication was 11 metres. He asked about the shape of the mast and if it could be added to within the term of the lease, i.e. 25 years. Mr. Howell, in time-honoured tradition, attempted to embark on a diatribe against various members of the Parish Council. He was firmly prevented from doing so. He then, yet again, attempted to ask questions concerning parish charities but was, yet again, advised to address any queries to the charity trustees. Mr. Fletcher remarked that, at the previous meeting, it was suggested that Elmham News should consider making public their financial accounts. He advised that this would not happen.

008 Street Lights (item 398)

• Paul Grainger will update PC on our attempts to engage Bill Borrett in discussions about controlling traffic speeds in the village. I feel we should also be asking Highways specifically why they are recommending that they need their own traffic survey prior to doing the feasibility study when we already have the results of the survey carried out by the police. It is difficult to understand why the police report is not sufficient.

- I can make no headway with Highways over the repairs to the muddy areas on the Safe Route to School across the green, and I will be raising the matter with our County Councillor after the elections.
- Norman Clarke and others involved with the railway company should be congratulated on installing and painting the new railway gates which are very smart and make the crossing far safer

Mr. Grainger has written to Mr. Green (Police Commissioner) on the issue regarding traffic speeds. He has also contacted Mr. Borrett (County Councillor) who is to encourage the police to help and also ask why another survey is required when one has already been done. Mr. Shoesmith previously brought up the question of a hedge in Eastgate Street. There have been no reports of injuries or vehicles scratched and it is considered, therefore, not to be an issue.

010 Eastgate Centre (item 400)

Mr. Labouchere said that he would like to stand down as a trustee of the Eastgate Centre. The Chairman of the Centre, Mr. Fitzalan Howard, said that the position does not need to be filled immediately.
