<u>Pre-Meeting Business:</u> The Chairman stated that Mrs. White was present as a representative of the local press and was not a member of the Parish Council.

<u>Public Participation:</u> Mr. Gower said that he was concerned by the speed of vehicles and the size of lorries travelling through the village. Mr. Grainger and Dr. Wade-Martins considered this to be a very relevant point. There is currently an advisory sign for vehicles in excess of 7.5 tonnes and it was wondered if Highways could be requested to make it compulsory. Mr. Labouchere said that it was a European route (vehicles up to 44 tonnes permitted) but felt there could be a better chance of getting it changed after Brexit.

Mrs. Payne asked if Mr. Seaman had made a planning application to remove trees from Prince William Wood. It was confirmed that nothing had been received in this respect.

Mr. Johnson repeated his previous worries regarding telecommunications masts and stated that house prices nearby would fall and the levels of illness would increase. He said that compensation could be obtained from the Parish Council in both cases.

Mr. Starling thanked the Chairman for a letter in response to his. He asked how many people supported the mast and how many had objected. He also wondered if dates of future Parish Council meetings, together with a note of the bank balances of the accounts, could be put on the website. He said that he had visited five neighbours to discuss the mast and they broadly supported his views. Mr. Wyatt disagreed with Mr. Johnson's assertions regarding the health risks. He said that he had closely investigated the website of Cancer Research U.K. and it clearly stressed that there are no links between cancer and mobile 'phone masts.

Mr. Fletcher stated that his son had worked on electronics for 35 years in the Foreign Office and had told him that there is no problem with the latest technology involving masts. He would, however, have preferred the mast to have been sited at the northern end of the village.

Mrs. McKinn asked where the mast was to be sited and the Chairman explained the location.

089 Shared Access – telecommunications mast (item 058)

The Chairman confirmed that responses had been received from Shared Access in respect of questions asked by the Parish Council. Members were content with the answers. If and when it is necessary to dig a trench around the perimeter of the field, there will be no interference with cricket matches. It is not desirable to have the mast painted green as the paint can be subject to fading and flaking. There will be two cabinets and the existing electricity supply will be utilised with a separate meter being installed.

The Parish Council had received three letters and one e-mail from residents criticising the proposal. Shared Access had received three letters (Mr. and Mrs. Starling, Ms. Ketteringham and Mrs. Cleall). There had been no letters in support sent to the Parish Council.

With regard to health issues, Mr. Labouchere referred to the Dunham mast which was erected in 2009. Nobody has complained of illness resulting from this mast since that time. He had spoken to the neurology department at the Norfolk and Norwich Hospital who confirmed that there was nothing linking oncological deaths to masts or any radiation emanating from them. Mr. Phillips could find no evidence on the internet to support problems caused by masts. Mr. Grainger had visited the Cancer Research U.K. website and their report advises that much research has been carried out. They cannot, however, find evidence of a causal link between telecommunications masts and cancer.

The Chairman had obtained information from:-

- a) Health and Safety Executive. There are very low levels of non-ionising radiation linked to masts but these are well within the permitted guidelines.
- b) Of com. They have identified instances which are a very small fraction of permitted levels.
- c) National Health Service. The levels are well below international guidelines and represent less than 0.005% of guideline values.

In answer to Mr. Fletcher's query regarding the siting of the mast, surveys had been carried out and the most suitable site identified. The church is a listed building and, because of the complexities that this produces, they tend to be avoided for mast siting purposes. Mr. Brown felt that giving the residents and visitors the ability to use mobile 'phones in the village would produce a safer environment, particularly in the case of emergency situations. The Chairman concluded by saying that evidence is needed for not proceeding with this project. Despite thorough research, no proof of any health issues had been identified.

Mr. Labouchere was of the opinion that all complaints have been addressed. He felt that the mast would be of enormous benefit to the village and the residents. He proposed that the project to install the mast should proceed. This view was seconded by Mr. MacEwan. Seven members voted in favour and there were two abstentions (Dr Wade-Martins and Mr. Fitzalan Howard – previously declared interest).

The Chairman stated that, in the extremely unlikely event of future legal action being taken, as suggested by Mr. Johnson, in respect of reduced property values or health issues, the body defending the lawsuit would be the District Council, not the Parish Council.

A technical problem had arisen as the deeds for the Playing Field could not be located, the transaction to purchase having been completed probably before 1925. Therefore, statutory declarations are to be prepared by the solicitors (cost £250 + VAT). Acceptance of this was proposed by Mr. MacEwan and seconded by Mrs. Keeble. All in favour.
